

## WAIVER

THIS AGREEMENT IS BETWEEN YOU AND RHOK HOLDINGS LTD (TRADING AS "IBOUNCE") AND RELATES TO YOUR USE OF OUR FACILITIES AT IBOUNCE TRAMPOLINE PARKS.

PLEASE PLAY SAFE, HAVE FUN AND ENSURE YOU HAVE READ AND UNDERSTOOD THE FOLLOWING TERMS BEFORE SIGNING THIS AGREEMENT.

In consideration of being granted permission to use the trampoline facilities and/or participate in fitness classes, games or other physical activities (the "**Activities**") at any iBounce Trampoline Park, I accept the following:

- I confirm that I am 18 years old or over.
- I confirm that neither myself nor any participant I have listed exceeds the specified weight limit of 19 stone (120kgs).
- I acknowledge and accept that participation in any of the Activities which involve the use of the facilities at any iBounce Trampoline Park carries risks of personal injury and in extreme cases, risks of paralysis and death. Examples of personal injury that may be sustained as a result of participating in the Activities include, but are not limited to, physical injuries such as cuts, bruises, other soft tissue damage, muscle strains, sprained or torn ligaments, concussion and bone fractures and emotional distress.
- I acknowledge and am fully aware that participation in the Activities and the use of trampoline facilities at any iBounce Trampoline Park requires a reasonable level of fitness and physical ability. I confirm that neither myself nor any participant I have listed have, or are recovering from, any medical impairment or condition of which I am aware that may prevent me and/or those participants from using the facilities or may increase the risk of injury to anyone.
- I understand and will ensure that any participants I have listed understand that Activities may be undertaken without direct supervision.
- I acknowledge that iBounce staff members have a difficult job to perform and that they are there to keep people safe. I will obey their instructions at all times and will ensure that any participants I have listed do the same. I understand that any staff member has the right to prevent anyone from using the facilities at any iBounce Trampoline Park for any reason whatsoever.
- I understand and will ensure that any participants I have listed understand that certain actions on trampolines carry higher risks of injury and that those injuries may be more serious. Similar risks are present when using the foam pit, air bags and basketball hoops. I agree to only perform actions that are reasonably within my capabilities and of which I am able to retain control of at all times.
- I understand that items of clothing or jewellery unsuitable for physical activity may present a risk of injury to myself or others. I agree and will ensure that any participants I have listed agree to wear appropriate clothing and to remove all jewellery/piercings prior to participating in the Activities.
- I understand that the grip socks provided at any iBounce Trampoline Park help to reduce the risk of injury. I agree and ensure that any participants I have listed agree to wear them at all times while participating in the Activities.
- I understand and will ensure that any participants I have listed understand that Rhok Holdings Ltd will not be held liable for any damage to property (either personal or third party) resulting from my use of the facilities and/or the listed participant's use of the facilities at any iBounce Trampoline Park.
- I voluntarily assume all of the risks of personal injury and ensure that any participants I have listed are fully aware of all risks of personal injury that may arise as a result of using the facilities or participating in the Activities at any iBounce Trampoline Park.
- I agree and ensure that any participants I have listed agree to release Rhok Holdings Ltd and its subsidiaries from any liability for any loss resulting from my/the listed participant's failure to comply with safety instructions found in any signage, instructional video, briefing or other source of information provided to me by staff members at any iBounce Trampoline Park or on the iBounce website.
- I agree to indemnify Rhok Holdings Ltd, its subsidiaries and its employees against all claims made by any other person in respect of injury, loss or damage arising out of or in connection with my own or the named participant's failure to comply with any safety instructions found in any signage, instructional video, briefing or other source of information provided to me by at any iBounce Trampoline Park or on the iBounce website.

- I consent to the use of CCTV monitoring at any iBounce Trampoline Parks for training, security and health and safety purposes.
- I agree to make Rhok Holdings Ltd aware of any physical or mental impairment of either myself or any participant I have listed which may affect my/their ability to understand any safety instructions. I agree to do this prior to arrival at any iBounce Trampoline Park.
- I confirm that any participant I have listed as being under the age of 18 complies with the terms of this agreement. I understand that I am responsible for any listed participant's failure to comply with this agreement.

By signing this agreement I declare that I have read and understood the above terms and that I agree to be bound by those terms. I understand that this agreement shall apply to all visits to any iBounce Trampoline Park and that I am required to inform a member of staff of any change which means I am no longer able to comply with any of the above terms.
